Qualifying Run - flat blue ribbon

BCAT - 18" triple streamer rosette

DCAT - 24" triple streamer rosette

FCAT & Above - 30" triple streamer rosette

Oshkosh Kennel Club will award a rosette for 1st, 2nd & 3rd place for Fastest Above Average for the weekend. Each breed's average speed will be calculated by totaling the top 20 dogs and bitches from the AKC's Fast CAT rankings from 2019. For example, the top 20 average MPH for Irish Setters is 25.00 MPH. If an Irish Setter has a run of 28.55, his (Above Average Score) would be +3.55. At the conclusion of Event #6 on Sunday the trophies will be awarded. Scores will be posted so everyone can keep track. To be eligible your breed must have no less than 10 dogs and/or bitches listed on the AKC's Points Ranking Page from 2019.

If you are anticipating earning any title above FCAT please notify the Fast CAT Secretary.

ENTRY FEE

\$20.00 pre-entry per dog per test (Includes \$3.50 AKC recording fee)

There will be a \$15.00 service charge for any returned check

Day of test entries are \$25.00 for each entry. Day of test entries accepted as space allows. A stand-by list will be created and these dogs will be allowed to run if time permits. Late entries by mail will be charged a \$5.00 Late Entry fee. The closing date is August 14, 2020. If the trial has not filled, day of show entries will be accepted up to 7 am and Noon for each day's respective trial and dogs not registered by that time will be considered absent. Incomplete, unsigned, or conditional entries will not be accepted. Entries will be acknowledged by email if legible email address is provided in the entry form.

CONDITIONS OF ENTRY

All dogs must have an AKC registration number and be at least one year of age on the day of the trial. Dogs may only run once per test. All entries must be accompanied with a Check payable to Oshkosh Kennel Club, Inc. to be valid. Entries received by phone, text or email will not be accepted. Incomplete entries or forms without a signature will not be accepted.

Fast CAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with the foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners Program. Dogs with breed disqualifications and monorchid/cryptorchid Dogs are eligible to participate.

WHAT IS FAST CAT

Fast CAT (Fast Coursing Ability Test) is a timed straight 100 yard dash for dogs. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced and dogs are run individually. Dogs are timed when they complete the 100 yard dash. The time is converted to miles per hour (MPH).

FORMULA: $204.545 / \text{RUN TIME} = \text{MPH}$

MPH X HANDICAP = POINTS (Rounded to the nearest 0.01 MPH)

A dog's handicap is determined by the height of the dog at the withers, a handicap is applied and points are earned.

18" or greater = Handicap multiplier - 1.0

12" to 18" = Handicap multiplier - 1.5

12" and below = Handicap multiplier - 2.0

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

BCAT = 150 points

DCAT = 500 points

FCAT = 1000 points

FCAT2 = 1500 points

FCAT#... For each additional 500 points

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection committee has the authority to disallow a dog's entry into a test. At roll call, all dogs will be measured by a wicket to verify handicaps. Bitches in season with either a visual inspection or a letter from a vet will receive entry refund. Lamé and unfit dogs will be excused without entry refunded.

Please do not bring bitches in season to the test!

TOP 20 BY BREED BY YEAR

The AKC fast cat website will feature the top 20 fastest dogs by breed by year national standings. The standings will be updated as event results are processed at <https://www.apps.akc.org/apps/fastcat> ranking

HOURS

Roll Call and visual inspection begin no later than 7:30 AM. It is the responsibility of each entrant to make an effort to be ready when their dog is called to the line. The runs begin at 8 AM and 1:00PM until all runs are completed. For the safety of our volunteers and participants, lightning is the only reason to cause the postponement and or cancellation of an event.

OKC FAST CAT INFORMATION

*ALL DOGS RUN AT OWNER'S SOLE RISK

*All dogs must be 12 months of age or older on the day of the test.

*All dogs must be leashed on trial property. No electronic or prong collars permitted on trial grounds.

*All AKC rules regarding sportsmanship and conduct apply.

- This is it rain or shine outdoor event. Please plan accordingly. Please bring your own shade, chairs and water.
- Run times will be scheduled as entries are received and an email will be sent to entrants with this information. If you need to have an earlier or later run time please contact the Test Secretary for an adjustment in your run time.
- The camp grounds are not completely fenced.
- The Fast CAT course is completely fenced.
- Bathrooms will be available.
- All dogs must be on a lead or created unless running.
- Owners are expected to clean up after their dogs.
- Each dog requires an individual entry form.
- You're responsible for controlling your dog or dogs and children.
- Bitches in season and lame dogs will be excused.
- The field committee is responsible for field safety and therefore in complete charge of all dogs and handlers on the field. In service to this responsibility, they have the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Dogs and or persons exhibiting conduct detrimental to OKC/AKC will be asked to leave the trial site by the field committee and may be disciplined by the AKC. Entry fees will not be refunded.

Suggested Best Practices for the Well-Being of the Dog Sport Participants

The AKC supports each club's informed decision to reschedule, postpone or cancel their respective events, as well as supporting clubs ready to hold events in locations that are open and permit gatherings. As events resume across the country, people need to feel safe while enjoying their dog activities. The AKC urges clubs to take appropriate precautions for the benefit of their participants. Events need to be held in a manner that emphasizes the safety of participants and event officials over efficiency.

The following is a list of suggested best practices that may be helpful when planning or attending an event. Event locations, facilities and dates will differ. With a situation that is continually evolving, it is up to the clubs to determine the guidelines that best fit their event. In order to inform participants, specific guidelines established by the club should be published in the premium, club website and posted on signage/flyers at their event.

General Practices

1. Clubs, officials and participants are required to follow state, local and facility guidelines that apply to the area and site where the event is held.
2. Practice social distancing consistent with current guidelines. Avoid congregating to the extent possible.
3. Consider wearing masks when in close proximity to others. Clubs should provide masks if desired for officials, judges and volunteers.
4. Consider wearing disposable or washable gloves.
5. Have plenty of hand sanitizers placed for people to use.
6. Wash hands as frequently as possible. Have disinfecting spray at bathroom facilities for people to spray door handles (or anything else they touch).
7. If you utilize portable toilets, please ask for a hand washing station to be delivered as well.
8. Avoid shaking hands or hugging.
9. Avoid touching dogs that are not your responsibility.
10. Avoid common use pens/pencils – bring your own.
11. Disinfect surfaces in common use areas as often as possible (tables, chairs, doorknobs, etc.) Clubs and facilities may consider not providing chairs.
12. Meals – Avoid or stagger group lunches/dinners if possible. It is recommended that clubs supply boxed lunches for judges and volunteers. Hospitality areas should avoid community items such as salt and pepper shakers, condiments, creamers,

etc. Participants should consider bringing their own lunches/drinks.

13. Parking areas – Park with sufficient distance between vehicles if possible.

Event Practices

1. Scheduling – Consider scheduling participants in blocks in order to reduce crowds.
 - Use SignUp Genius (free downloadable app) or another online scheduling application if possible or the event secretary assigns dogs to a time block. Possible 20 minute blocks with 10 dogs per block.
 - Set aside times for day-of-event entries – assign day-of-event participants a time and number.
2. Ask participants to wait by their vehicles until immediately prior to their block time.
 - Use Remind (free downloadable app) or another online reminder application to inform participants when their block is to line up.
 - Participants provide cell phone numbers for the event secretary to call or text.
 - Use a bull horn or PA system to inform participants when their block is to line up.
3. Roll call and inspection committee functions can be performed in the parking areas one dog at a time.
 - Owners of females swipe their own dogs and show the inspection committee the tissue.
 - Wicket measuring can be done in the parking area. Inspection committee members performing the wicketing should wear masks and gloves.
 - Wickets should be wiped down between dogs.
4. In order to minimize the gathering of people, clubs should consider holding concurrent events rather than consecutive events.
5. Safe handling of paperwork and payment for day-of-event entries.
 - Go cashless as much as possible – encourage use of PayPal, Google Pay or EWallet.
 - Cash for day-of-event entries – inform participants they should have correct change.
 - Individuals handling paperwork and entry fees should wear gloves.
6. Separate participants when lining up to run - place cones or paint lines at intervals in the area that dogs line up to run. Move up as the dogs are run.
7. Huntmaster, Lure Operator, Paddock Master and, if running a CAT event, the Judge, should maintain a minimum of 6 foot distance from each other and participants.
8. Trial Secretary should wear gloves to handle paperwork.
9. Consider having someone wearing gloves handing out ribbons or rosettes. No self-serve boxes.
10. Have a separate table at least 6 feet from trial secretary table for day-of-event entries, ribbon distribution and questions.

Fast CAT Specific

11. Designate one person in the release area and one person in the catch area to open and shut the gate with gloves. If this can't be done, have paper towel or tissues for the handler to use when opening and closing gates and a trash can nearby for disposal of tissues.
12. If you are a catcher or releaser, consider using gloves when handling dogs and leashes.
13. Timer table – only the person timing is allowed in this area. Put a drop basket for run tickets at least 6' away (if you use run tickets). Timer should handle all paperwork with gloves.

Policies that Have Been Temporarily Suspended/Modified

1. Event Application Late Fees – Event application late fees are waived through the end of October. This provide clubs more flexibility in planning or rescheduling their events.
2. For events cancelled in 2020, AKC will apply Event Application fees to the club's next event of the same type.

Participants are expected to follow state, local government, facility and event guidelines. Clubs should be prepared to enforce the guidelines that apply to their event.
